

MINUTES OF THE MEETING HELD ON 04.05.2013 AT 3.00 P.M. IN THE CHAMBERS OF SECRETARY, APREI SOCIETY WITH ALL SERVICE ASSOCIATIONS TO DISCUSS ON MODALITIES FOR EFFECTING PROMOTIONS :

All the Service Associations of APREI Society were invited for a meeting on 04.05.2013, to discuss on modalities for effecting promotions to all cadres.

The following Service Associations have attended the meeting:-

- 1) APREI Teachers Association;
- 2) Gurukula Vidyalayala Telangana Udyogula Sangham,
- 3) APRJC Lecturers' Association,
- 4) Telangana Residential Jr.College Lecturers' Association,
- 5) APREI SC, ST, BC & Minorities Teaching & Non-Teaching Association,
- 6) APRJC Direct Lecturers Association,
- 7) APREI Society Non-Teaching Employees State Union,
- 8) APR Junior College Principals Association,
- 9) APR Physical Education Teachers Association,

At the outset the Secretary, APREI Society informed all the Service Associations regarding frequent demand from all the Service Associations as well as individuals regarding effecting promotion stating that, there were no promotions since long time and most of the staff members are retiring from service without getting the benefit of promotion. The Secretary, APREI Society explained the need to take up promotions in view of more retirements, increase of workload on the existing staff and invited suggestions from all Service Associations with regard to effecting promotions. The copies of note already submitted to Vice-Chairman for permission to effect promotions and permission to effect transfers to APRJC Lecturers were circulated to all the Service Associations.

The opinions expressed by the Service Associations are as under:-

APREI Teachers Association:

The APREI Teachers Association requested for re-allotment of local cadres as per the study of the incumbents on par with APTWREI Society.

It is informed to the Association that, the matter is not under the purview of the Society. Also in view of pendency of the matter before the

Hon'ble High Court, the matter will be examined after receipt of final orders from the Hon'ble Court.

Gurukula Vidyalayala Telangana Udyogula Sangham:

The Association stated that, they have no objection to effect promotions on Zonal basis.

APRJC Lecturers' Association:

The Association requested for immediate transfers to the Junior College Staff as they have not come under the BC Schools bifurcation. The Association requested that the place of posting of promotees should be temporary subject to attending general counselling for transfers.

Telangana Residential Jr.College Lecturers' Association:

The Association requested to take transfers immediately as the Junior Lecturers are sufferers in Society for a long time and there are only one or two APR Junior Colleges in every Zone. Most of the JLs are away from their families years together and suffering mentally.

APREI SC, ST, BC & Minorities Teaching & Non-Teaching Association:

The Association expressed their willingness to proceed with promotions. The Association requested for posting of Principal in Minority Schools from Minority Community only. The Association also requested to follow rule of reservation in promotion including backlog vacancies.

APRJC Direct Lecturers Association:

The Association requested for early finalisation of JL seniority list and to effect promotions to the post of Principal of APR Junior Colleges. The Association was informed that, the matter is before the Court.

APREI Society Non-Teaching Employees State Union:

The Association requested for repatriation of staff to their allotted local cadres wherever there are vacancies to accommodate them, as no non-teaching staff member approached the Govt. Also to release Zone wise seniority lists of non-teaching staff before effecting promotions.

APR Junior College Principals Association:

The association satisfied with the proposals submitted to Vice-Chairman for effecting transfers to the Junior Lecturers.

APR Physical Education Teachers Association:


The Association requested to treat the Physical Education Teachers as Teaching Staff and to create channel for promotion from the cadre of Physical Director to Principal of APR Schools.

All the Service Associations have requested for release of Zonal Wise seniority lists before promotions.

All the Service Associations were informed that, the grievances if any on allotment of local cadres in accordance with the orders of Government issued in G.O.No.131 can be examined only after receipt of final orders of Hon'ble High Court pending court cases. It is also informed that, the zonal wise seniority lists of PG Teachers & TG Teachers will be displayed in Society Web site along with Caste, qualifications of each individual with a request to submit representation if any. After receipt of orders from Vice-Chairman on the proposals submitted by the Society for effecting promotions, necessary action will be initiated in the matter.
